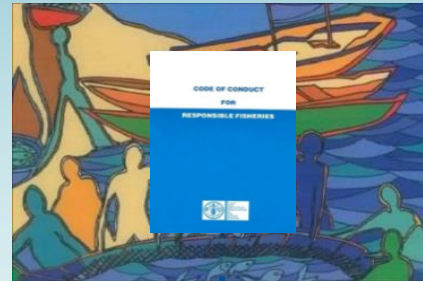

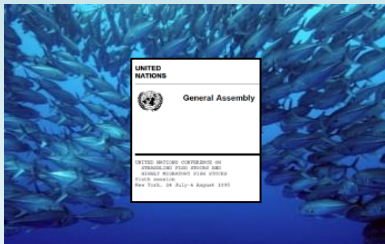
FAO Compliance Agreement (1993)*

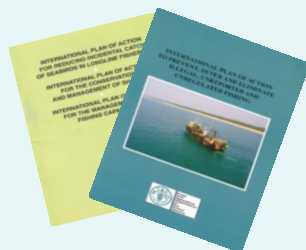
UN Fish Stocks Agreement (1995)*
